Alden House Has Had a Facelift!

New Roof and Siding Shingles; Leak and Chimney Repairs

The Alden House got a well deserved external freshening in September with new red cedar roof shingles and white cedar siding all around. We're not exactly sure when the siding was last done on the house, but when contractor Lew Conant pulled off the West siding, it was discovered that the last work on that end had been a "do over" and the underlying shingles had disintegrated into a black powder!

Fortunately not all of the walls were in that bad of a condition, but because of a number of leaks affecting the interior of the house, the Executive Board decided to have all of the shingles replaced at the same time and take advantage of the discount on labor. In the process, inspection of the chimney work done a few years ago, revealed some problems. Will Gwilliam, our architectural historian, reports that "building movement from sun heat, expansion and contraction in the winter allowed water to get in and freeze. Probably the same actions that have been occurring in the past."

The total cost for all repairs was \$40,050. While the Alden Kindred has invested endowment funds, as well as some reserve funds that are sufficient to cover these repairs, this is not a great time to cash in our investments or to deplete our reserves. Members and friends are asked to contribute to the "Buy a Shingle" campaign (see insert in



Work on the Alden house involved removing 700 sq. ft. of red cedar shingles from the roof, laying down ice and water shield, new flashing, ridge vents boards, and installation of new 5/8" Tapersawn Red Cedar shingles; removal and replacement of 2500 sq. ft. of white cedar siding on all four sides of the house, as well as chimney repair.

Donors of \$100 or more have the opportunity to receive one of the shingles taken off of the Alden House.

This is an chance that doesn't come around more than once every 30 years or so! Please consider supporting this necessary preservation of our National Historic Landmark property – we've saved less than 100 shingles on a "first come, first served" basis, so **do not delay!**

Scholarship Reminder

The basic requirements to receive the **Dr. Donnell B. Remembrances

The Alden Kindred recently lost two long-time members of our family.

John Clarke Alden, 80, died on July 28th. At our annual meeting in August, Linda Osborne, President of the Alden Kindred, read the following eulogy:

I met John Alden many years ago as a co-AKA Board member. John was a true gentleman and very proud of his Alden heritage. I was honored to serve with him on the Board

John was our first fundraising committee (in the beginning all by himself). He was responsible for Alden nails, three Alden glass bottles, the Alden blanket, mugs and many other items. He was a major sponsor of our Alden Golf Tournament and also played in the tournament with a foursome for most of the years it was held. He was always there to support his family organization, contributing whatever he could.

Some years ago, John told us the story of the time when he was younger and got stopped for speeding. When the officer came over to the car and asked his name, he politely stated it was John Alden. However, the police officer did not believe him, and since John had forgotten his license he could not prove who he really was. No matter how much he tried to convince the officer that indeed he was John Alden, it was to no avail. The officer told him to stop kidding around, so John gave up and said his name was John Clarke!

Although I had not seen John for about a year, we communicated regularly by e-mail until about two months ago. Even though he knew his lung cancer was stage 4, John didn't give up. He had an upbeat attitude and remained upbeat.

Alicia and I attended his funeral and it struck me how precious he held his heritage. He had requested that the Alden symbol, the scallop shell, be put on his casket. The Alden Kindred logo was on his name plate, and we were called over to see it at the end of the service. Experiencing this was very touching, along with the graveside service that included a volley fired by the Chelmsford Minute Men, and the folding and presentation of the U.S. flag by the United States Air Force in which John served.

I can imagine that John Alden is up in Heaven organizing some historical events and reuniting with his Alden family.

Rest in peace, John Alden, we will miss you!

Robert Philip Winterhalter, 81, died on September 29th. Bob served as a member of our Executive Board for many years and was Treasurer for a term. He was a resident of Ashland, Massachusetts, for most of his life, and for the last ten years he was the Transportation Director for the Millis Public Schools. He and his wife, Cynthia, owned and operated the Big W Trans, Inc., a school, charter and transit bus service in Ashland and surrounding towns for over 25 years. He served on town committees, including the Historical Commission and the CPA, and in July was given a Town of Ashland Civic Pride Award by the Selectmen.

Bob was a staunch supporter of the Alden Kindred, whose solid and dependable advice will be missed.

President's Corner

Duxbury Native Joins Alden Staff



The Alden Kindred has seen many changes since last year when we received our plaque designating our Site as a National Historical Landmark.

After the retirement of Alden (Rink) Ringquist, Director, and James Baker, Curator, in 2009, we decided to slow down a bit and "catch our breath" during the winter

months. I called a special Board meeting in February so that the Board could discuss what they would like to do regarding personnel and the opening of the House. At that meeting, the Board directed the Personnel Committee to reorganize and authorized it to draw up a job description, advertise, and hire a "Seasonal Manager." Several Board members volunteered to be on the Committee as well as Chair, Alicia Williams, and myself who were already on the inactive Committee. In addition to the above named, Bonnie Conant, Mary Ruth Duquette, and Pauline Kezer volunteered and were appointed. Alicia drafted a job description and placed the ads. We received several excellent applicants for the position. After all the interviews, Matthew Vigneau of Duxbury was hired. Matthew is a graduate of Ithaca College in N.Y. He has a background in history and is currently attending Harvard University Extension School to obtain his masters in Museum Studies.

After Matthew had been on the job for a short time, it was evident that his enthusiasm and excellent job performance were just what the AKA needed. The Committee, on my recommendation, decided it was in the best interest of the AKA to offer Matt a one year contract rather that negotiate a continued limited contract after October 15th. It made more sense to keep him on a consistent contract and schedule with the Haunted House, the Annual Appeal, the Annual Dues bills, and other Administrative duties that needed attention on a regular basis.

By eliminating the Office Manager/Gift Shop position and not filling the Curator and Directors positions, we were able to reduce our payroll to around \$35,000. Dodie Cook returned for the summer as our docent.

The other important news this year was the extensive water damage we had during the heavy spring rainfall. As a result, we were in need of some major roof repairs and siding that needed immediate attention to preserve the Alden Homestead.

The hours of operation changed this past summer and the house was open from Wednesday through Saturday from 12:00 – 4:00 instead of the previous Monday through Saturday schedule. We also had a shorter season this year as we closed on Labor Day Weekend, but were open Saturdays in September.

He is also responsible for the day-to-day operations of the Kindred, including bookkeeping, membership records, gift shop and mail order, event planning, and much more. 
Alden House Provides the Backdrop for Genealogical Television Show


